

# Sherburne Wrestling Festival 1972 - June 30 & July 1

This will be at the new Sherburne-Earlville High School in Sherburne, N.Y. The weights are 105, 115, 125, 135, 145, 155, 165, 175, 190, and 215 for high school; 120, 126, -35, 142, 150, 158, 167, 180, 195, and HWT for open (2# scale allowance).

Weigh-ins are 2-5 p.m. on Friday, June 30 for high school and 6-9

a.m. on Saturday, July 1 for open.

The awards for high school are medals for 1st, 2nd, and 3rd place. The open division will have trophies for 1st, 2nd, and 3rd. The will also be two team trophies, outstanding wrestler plaque, most falls, and quick pin.

NCAA and high school rules will be used.

# Northeastern Wrestling Tournament - July 7 & 8

The place is LeMoyne College in Syracuse, N.Y., and the entry deadline is 7 p.m. on July 7. Fee is \$3 prior to July 1 and \$4 after July 1. High school weights are 100, 107, 114, 121, 128, 134, 140, 147, 157, 169, 189, Unlimited and matches are 1-2-2. Open weights are 120, 128, 136, 144, 152, 160, 169, 179, 192, 215, Unlimited and matches are 2-2-2. Awards will be given to the first three places in all weight classes in both divisions, the outstanding wrestler of each division, and the 1st place team in each division.

Dorm accommodations are available for 250 on a first-come basis at a cost of \$3 per person. There are several motels within a two-mile radius. Dorm rooms may be obtained from 4-10 p.m. on Friday and check out is 10 a.m. on Saturday. Bring your own bedding & linen.

Weigh-in is from 4-7 p.m. on Friday. Prelims will be at 7:30 p.m. followed by quarter-finals at 9:30 p.m. The Saturday weigh-in will be at 7:30 a.m. with a two pound allowance. Challenge matches (so everyone will have a chance to wrestle more than once) will be held on one mat beginning at 9 a.m. The semi-finals will start on 3 mats at 9:30 a.m. with consolations on 4 mats at 12:30 p.m. and finals at 1:15 p.m.

No one will be seeded unless he sends in an application & release prior to July 5. The address before June 25 is Box 205, Treadwell, N.Y. 13846. The address after June 25 is Wrestling Camp, LeMoyne Col-

lege, Syracuse, N.Y. 13214.



# Notes on The Corning Tournament

# April 8, 1972 at Corning Community College

- \* The high school division attracted a record field of 198 grapplers.
- \* Pennsylvania Olympic Club won the team championship. The top Rochester area finisher was the Canandaigua Elks team, which finished in a tie with Pioneer Wrestling Club for third place.
- \* Individual winners from the Rochester area included Canandaigua ' s Jim Hartwell at 147 pounds and Gates-Chili's Alex Macaluso at unlimited.
- \* Classiest battle of the tourney was a rematch of this year's finals of the 105 pound class of the New York State intersectional tourney. In that one, Bob Sloand of Niagara-Wheatfield had pinned Canandaigua's Mike Chappelle. In this return meeting at Corning, however, Section 6 champ Sloand was forced to settle for a referee's overtime decision victory. The two rivals competed at 114 pounds in the Corning match, and once again, it was a final round pairing.
- \* Although Canandaigua had only one champion, the Elks did have five finalists. Besides Hartwell and Chappelle, the others were Gene Gigliotti, Bruce Hadsell, and Dave Colf.
- \* Bob Hadsell, an 8th grader from Canandaigua, gave Section 6 champion Mike Arnold a real battle at 100 pounds but lost by a very narrow, one point margin. Arnold wrestled for Pioneer.
- \* It was a rough tournament for Irondequoit High's Twelve Team. Todd Campo drew Jim Hartwell as his first round opponent at 147 pounds and although Campo made a good showing, he lost a 6-1 decision. Campo may have placed had he not drawn such a tough first round opponent. Teammate Jay St. James lasted only 27 seconds against Doug Kimball in the 121 pound class. Kimball had no team affiliation. Two Twelve Teammembers were losers by one point margins. A last moment escape cost Mark Purdell his match at 134 pounds with Joe Burgey (no affiliation) 8-7 while at 169 pounds, Don Martynec earned a point riding time but it wasn't enough and he lost 4-3 to Ronald Thompson of the Orange County Grapplers. But all was not bad for the Twelve Team: capt. Joe Eveland took a 4-1 decision over Chris DePerno of West Dryden Athletic Club in opening round action.
- \* Three Spencerport wrestlers competed. Kevin Murray wrestled in the 121 pound class for the Canandaigua Elks while Steve Brongo went for the Gates-Chili Recreation Club at 100 pounds and brother Ken Brongo grappled without team affiliation. Murray got a near fall on Phillip Roblee of the Pioneer Wrestling Club but wound up the loser, 9-5. The Brongos likewise lost their opening round matches, Steve by a 10-2 decision to big Doug Howland of NVAC and Ken by a 2-0 margin to Dave Manos of Pennsylvania Olympic Club. Ken was at 128 pounds.
- \* Trophies were given to the top four finishers of each weight class, both open and high school division.
- \* Midway through the first round, it was announced that there would be no wrestle-backs. Only semi-final losers could go for 3rd place.





Earl Fuller, R.I.T. varsity wrestling coach, is Director and James Howard, Oswego State varsity wrestling coach, is assistant director.

On campus residents pay \$80.00 for tuition, room, and board. Commuters pay \$50.00 for tuition and lunches. All who enroll must make a deposit of \$40.00 not later than July 21 for the first session and July 28 for the second session. The balance may be paid on arrival. No refunds will be made after applicants have been accepted.

Subjects to be covered include Orientation and basic wrestling summary; pin combinations; reversals; leg wrestling; floating and control; A.A.U. and Olympic Wrestling; Favorite Holds of Great Champions; Riding and Control; Movies - N.C.A.A. Championships.
